Qualifications for Holding Office

Pursuant to W.S. 6-10-106, a person convicted of a felony is incompetent to hold any office of honor, unless he has had a complete and full restoration of rights, not just voting rights. If you have any questions regarding your ability to hold office, please ask the County Clerk for clarification.

ALL COUNTY OFFICES, INCLUDING DISTRICT ATTORNEY

No person except a qualified elector shall be elected or appointed to any civil or military office in the state. (Wyo. Constitution, Art. 6, Sec. 15)

COUNTY ASSESSOR

In addition to being a qualified elector, the county assessor shall own real property in the county in which he is elected. (W.S. 18-3-201)

COUNTY ATTORNEY

In addition to being a qualified elector, the county attorney shall be a member of the bar of Wyoming. (W.S. 18-3-301)

DISTRICT ATTORNEY

In addition to being a qualified elector, the district attorney shall be a licensed attorney for at least four (4) years and a member in good standing of the Wyoming state bar immediately prior to his election. (W.S. 9-1-802)

INSTRUCTIONS

1. Candidate's Campaign Committee Defined - W.S. 22-1-102 (a)(vii)

- "Candidate's Campaign Committee" means every group of two or more persons who join together for the purpose of raising, collecting or expending money to be used in the aid of the election of a specific candidate for public office.
- If more than one committee forms to support the candidate, the candidate shall designate which committee shall be his or her principal campaign committee.

2. Organization of a Candidate's Campaign Committee - W.S. 22-25-101(b)

- A statement of formation is required when a candidate's campaign committee is formed, whether before the election to aid in the campaign, or after an election to defray campaign expenses.
- The statement of formation shall include:
 - (a) name and mailing address of the committee;
 - (b) name and residence address of committee chairman and treasurer, who must be separate individuals;
 - (c) date committee formed; and
 - (d) the purpose of the committee.

3. Filing Date - W.S. 22-25-101(b)

- Within ten (10) days after formation of the committee

4. Filing Office - W.S. 22-25-107

- **County Clerk** – Candidates and candidate's campaign committees for district attorney, county and municipal offices, magistrates, school and community college district trustees file with the county clerk.
 - *Note:* Candidates and candidate's campaign committees for statewide office, the state legislature, circuit, district or Supreme Court are required to file electronically at <https://www.wycampaignfinance.gov>. This form may not be used.

5. Amendments to Statement of Formation - W.S. 22-25-106(e)

- File amendments to reflect any changes, such as change of chairman or treasurer, change of address, or change of name, with the respective filing office.

6. Penalties - W.S. 22-26-112(a)(ix)

- (a) Unless a different penalty is specifically provided in this code, the following acts, if knowingly and willfully committed, are misdemeanor offenses punishable by not more than six (6) months in a county jail or a fine of not more than one thousand dollars (\$1000), or both:
